## 62 Organizations Respond to Chancellor Syverud

May 18, 2018

Dear Chancellor Syverud,

We appreciate the prompt response of your office to our groups' letter, and we commend your commitment to the ideals of freedom of expression and a campus environment free from the harassing and discriminatory behaviors that impede it. We are concerned, however, that the steps taken to address the intolerant, harassing behavior both inside and outside of the event hall during Ambassador Dayan's talk were inadequate to preserve the right to freedom of speech and assembly of the event participants, and that the university's responses may have been mitigated by the anti-Zionist nature of the harassment.

Please understand that while your university's <u>anti-harassment</u> and <u>non-discrimination</u> policies provide essential protection from behaviors that impede expression and full participation in university life, they only afford such protection to students who fall into certain categories — race, color, creed, religion, sex, gender, etc. — leaving other students unprotected in the face of the exact same intolerant, harassing behaviors, and vulnerable to the effects of those same behaviors. We have found that without protection from harassment, free speech rights are curtailed. Harassment and free speech are intrinsically linked. Students who fear they will not be protected from harassing behaviors do not feel free to express their beliefs and opinions in the classroom, in the dorm or in the quad.

Unfortunately, this is the experience of many Jewish and pro-Israel students across the country. Far too often, anti-Zionist harassment is left unaddressed and Jewish and pro-Israel students are bullied into silence. That is why we hope you will consider our letter's recommendations for ensuring that all of your students — including those who identify as Zionist — are equally protected from the harassment and discrimination that would limit their free expression and full participation in campus life. In particular, we urge you to make a formal statement committing Syracuse University to applying the same stringent standard prescribed by your university's anti-harassment and anti-discrimination policies to each and every student, regardless of identity, belief, opinion or legally protected status. It is a simple step that will go a long way toward protecting free speech, encouraging a diverse range of views for students to learn from, and ensuring a campus free from harassment and discrimination.

We look forward to seeing such a statement guaranteeing the equitable treatment of all students on your campus.

Dear Ms. Rossman-Benjamin:

We are in receipt of your May 15, 2018 e-mail sent on behalf of the 62 organizations you Undersigned regarding inclusivity and free expression at Syracuse University. We appreciate your concern regarding these important issues and want to use this opportunity to confirm the University's commitment to providing an environment for our students, faculty, staff, and visitors that is free from discrimination and harassment.

As reflected in the University's anti-discrimination policies, including, for example, the University's Anti-Harassment Policy and the Non-Discrimination and Equal Opportunity Policy Statement, we unequivocally reject bigotry, intolerance and ignorance of any kind. There is absolutely no place at Syracuse University for behavior or language that degrades any individual or group's race, ethnicity, sexuality, gender identity, disability or religious beliefs.

Putting our words into action, the University acted swiftly and appropriately to ensure that Ambassador Dayan was able to deliver his lecture and participate fully in a question and answer session. Two individuals (not in any way affiliated with Syracuse University) who attempted to disrupt the lecture were removed from the building by our Department of Public Safety. A small protest outside the building did not interfere with the proceedings going on inside the building.

As an academic institution committed to free expression and continuous learning, we support the robust exchange of ideas. We will always welcome lecturers who advance our community's understanding of complex and controversial issues. We very much appreciated Ambassador Dayan's willingness to come to Syracuse University to advance that understanding.
