Re: Regents action needed to prevent institutional politicization and protect student safety and equal access

Dear Chair and Members of the University of California Board of Regents:

We write as a coalition of education, religious, and civil rights organizations committed to equal access, nondiscrimination, and the integrity of public education. Since October 7, 2023, antisemitism on University of California campuses has surged, and Jewish students - and students perceived as “Zionist” or “pro-Israel” -- have faced unprecedented harassment, intimidation, and exclusion. The [report](#) *When Faculty Take Sides: How Academic Infrastructure Drives Antisemitism at the University of California* concludes that this crisis is being fueled not only by episodic student conduct, but by UC’s own academic infrastructure -- faculty and academic units using UC authority, including classrooms, departmental platforms, and official UC-branded channels, to advance political agendas as institutional practice.

What must be made explicit and enforceable is the distinction between protected individual expression and institutional use of University authority. Faculty, staff, and students retain full rights to express political views in their personal capacities, but UC’s instructional authority, official unit communications, and UC-branded platforms should not be used to carry organized political advocacy into the University’s academic life as an institutional program. In the cases documented in the report, that politicization has centered on organized anti-Israel activism and has helped fuel a surge of antisemitism and hostile or exclusionary conditions for Jewish students and others perceived as “Zionist” or “pro-Israel.”

When institutional authority is used this way, political agendas can appear to carry the University’s endorsement, academic norms break down, and affected students face harassment, intimidation, and exclusion. The report describes the same pattern across UCLA, UC Berkeley, and UC Santa Cruz: academic units using websites, communications channels, and programming to push one-sided messaging; faculty influence concentrated

in key unit roles; and instructional settings being used to steer students toward political activity.

This is a Regents-level governance matter. Regents Policy 2301 [describes](#) a “moral and contractual relationship” obligating UC to provide a quality education, ensure public confidence is justified, and keep the University “aloof from politics” rather than functioning “as an instrument for the advance of partisan interest.” The report’s findings raise urgent concerns that UC is failing to maintain those standards. The report also documents that, despite UC’s December 2024 resolution agreement with federal authorities to address systemwide discrimination and harassment of Jewish students, patterns of faculty-driven conduct that fuel antisemitism have continued -- rooted in institutionalized political activism that UC has not consistently stopped.

We urge the Regents to act. Enforce UC’s existing rules -- and strengthen them where needed -- to prevent faculty and academic units from using UC authority, resources, classrooms, and UC-branded platforms to advance political advocacy as institutional practice. This is not a request to police beliefs or private speech. It is a request to restore enforceable institutional limits that protect UC’s academic mission, safeguard equal access to UC educational programs for all students, and rebuild public trust that UC’s academic units operate as scholarly institutions rather than political actors.

Finally, we respectfully request that the Regents engage in a substantive discussion of the report’s findings and recommendations at their upcoming meeting.
